ISSUE: Contract Extensions for Grantees

ISSUE: First-Time Homebuyer Program

REPORT, DISCUSSION, & OPTIONAL VOTE: Discuss the First-Time Homebuyer Program and consider allocating funds.

BACKGROUND:

Next month, the SCHT will make awards using funds allocated by the Iowa Finance Authority (IFA). These funds are provided to the SCHT annually and support the majority of the SCHT's programs and projects. One program funded through this annual allocation is the First-Time Homebuyer Program.

The First-Time Homebuyer Program has been implemented in two iterations. In both cases, eligibility requirements generally mirrored IFA's FirstHome Program, and assistance was provided as a \$5,000 grant to first-time homebuyers. The grant is issued at closing and may be used toward down payment or closing costs.

The program has been well received by lenders due to its streamlined requirements and the fact that the grant does not require repayment or a legal security instrument. As a result, implementation has been largely seamless.

Each iteration of the program funded 10 households, with each household receiving a \$5,000 grant. From a staff perspective, administration of the program has been straightforward and has not required a significant time commitment.

What, if any, changes should be made to the program? How much funding should the SCHT allocate for 2026 awards?
